Admission to trading of the shares of the company SUNRISEMEZZ PLC on the EN.A. PLUS segment of the Alternative Market of the Athens Stock Exchange

SUNRISEMEZZ PLC ("SUNRISEMEZZ" or "Company") announces that the Athens Stock Exchange ("ATHEX"), following the meeting held by the Listings and Market Operation Committee on 20 October 2022, approved its application for the admission to trading on the EN.A. PLUS segment of the Alternative Market of ATHEX ("EN.A. PLUS") of its shares (the "Admission"), subject to the achievement of sufficient free float of its shares upon the completion of Piraeus Financial Holdings S.A.' corporate action ("Piraeus Financial Holdings" or "PFH") (share capital decrease and distribution in kind to its shareholders of the shares issued by SUNRISEMEZZ and held by PFH – the "Corporate Action").

Piraeus Bank S.A. is the nominated adviser of the Company ("EN.A. Nominated Adviser").

The Company's sole purpose is holding and managing mezzanine and junior notes, issued in the context of the securitization of the Sunrise I and Sunrise II portfolios of Piraeus Bank S.A. The Company's shares are expected to commence trading on Monday, 31 October 2022, following the completion of the Corporate Action of PFH. Further information on the Company and its shares, including the risk factors, is disclosed in the Admission Document published on 20 October 2022, in electronic form, on the websites of ATHEX, the Company and the EN.A.
