



## UPDATE OF INVESTORS ON THE APPOINTMENT OF A BOD MEMBER

"Attica Bank S.A." ("Attica Bank") announces to the investors the following:

At its meeting on 04.09.2024, the Board of Directors of Attica Bank accepted the resignation of Mr. Richardos Lampiris and proceeded with the reconstitution of the Corporate Governance, Nominations, Human Resources, and Remuneration Committee.
