### Morgan Stanley and Athens Stock Exchange 3<sup>rd</sup> Greek Investment Conference

Athens Stock Exchange is again partnering with Morgan Stanley for the **3<sup>rd</sup> Athens Stock Exchange Greek Investment Conference** on December 2-3, 2024, at Morgan Stanley's conference center in London. The event will bring together 37 large- and mid-cap ATHEX-listed companies and is organized in collaboration with ALPHA FINANCE, EUROBANK EQUITIES, NBG SECURITIES, and PIRAEUS Securities.

The conference will be inaugurated by **Prime Minister Kyriakos Mitsotakis**, who will engage in a closed roundtable discussion with institutional investors followed by a fireside chat with Morgan Stanley representatives. Additionally, **Alexis Patelis, Chief Economic Advisor to the Prime Minister**, will participate in panel discussions with Morgan Stanley strategists.
